How to use this bulletin

To learn more about a project:

- Click the name of the project to view digital documentation.
- Submit a request online to review the project file at <u>Bellevuewa.gov/city-government/departments/city-clerks-office/public-records/development-services-records</u>
- Call the planner assigned to the project to arrange to review the project files. The planner's contact information is in the notice.

To comment on a project:

- Send your comments in writing to the Development Services Department. Be sure to include your name and address.
- Comments will be accepted until the time a staff report is prepared for the decision or recommendation, with a minimum comment period of at least 14 days (30 days for shoreline projects).
- If you submit a written comment, we will send you a copy of the notice of decision or recommendation.

To appeal a permit decision or SEPA determination:

- You must have filed a written comment expressing your concerns before the decision was made.
- Any appeal of a DSD decision to the Hearing Examiner must be received by the City Clerk's Office no later than 5 p.m. on the appeal deadline indicated on the notice. The appeal must include a written statement in the form described in LUC 20.35.250.A.2 together with an appeal notification form.

- An appeal of a shoreline decision is made to the State Shoreline Hearing Board, must be in writing, and must be filed within 21 days of the date the DSD decision is received by the State Department of Ecology (DOE). The DSD decision will be sent to DOE by the close of business on the date of this

General Information Regarding Use of Optional DNS Process

When the SEPA field indicates a Determination of Non-significance (DNS) is expected, the optional DNS process is being used and a DNS is likely. This may be the only opportunity to comment on the environmental impacts of the proposal. The proposal may include mitigation measures under applicable codes, and the project review process may incorporate or require mitigation measures regardless of whether an Environmental Impact Statement (EIS) is prepared. The Threshold Determination will also be noticed in a subsequent issue of this Weekly Permit Bulletin. A copy of the subsequent Threshold Determination for the proposal may be obtained upon request.

Project Name: Shoreline Master Program (SMP) Land Use Code Conformance Amendment

Description: The City Council is being asked to hold a public hearing on a conformance amendment to the City's SMP, which is limited to amendments to the Shoreline Overlay of the Land Use Code (LUC 20.25E). The City of Bellevue and the Washington Department of Ecology are accepting comments on the proposed SMP amendments, which include draft amendments to reconcile provisions within the SMP with recent amendments made elsewhere in the Land Use Code following the adoption of Ordinance No. 6670, removing references to the former East Bellevue Community Council; and Ordinance No. 6673, which removed appeals to the City Council on Process I and Process III Hearing Examiner decisions and recommendations. Proposed amendments to the Bellevue SMP are available for review at www.bellevuewa.gov/smp-conformance and at City Hall, 450 110th Ave NE, Bellevue, WA 98004.
