RE: Short-term Extension of the Services Agreement between American Traffic Solutions, Inc. ("ATS") and the City of Bellevue ("City")

On April 13, 2009, the parties entered into an Agreement for the provision of photo enforcement services ("Agreement"). The Agreement expires on April 12, 2014.

To allow the parties sufficient time for negotiation of a longer-term extension of the Agreement, the parties hereby agree to a month-to-month extension of the term of the Agreement. The Agreement shall automatically renew for subsequent 1-month periods unless either party provides 30-days' notice of its intent not to extend the term; provided, however, that the month-to-month extensions under this letter ("Letter Agreement") shall not cumulatively exceed six (6) months.

By signing below, the parties acknowledge agreement with the terms set forth in this Letter Agreement.

Attachment "B" INSURANCE REQUIREMENTS

ATTACHMENT "B"

INSURANCE REQUIREMENTS

The Contractor shall procure and maintain for the duration of this Agreement insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work hereunder by the Contractor, his agents, representatives, employees or subcontractors. The cost of such insurance shall be paid by the Contractor, insurance shall meet or exceed the following unless otherwise approved by the City.

A. Minimum Insurance

- 1. Commercial General Liability coverage with limits not less than \$1,000,000 per occurrence / \$2,000,000 annual aggregate,
- Stop Gap/Employers Liability coverage with limits not less than \$1,000,000 per accident/disease.
- Business Automobile Liability coverage with limits not less than \$1,000,000 per accident for any auto,
- 4. Workers' Compensation coverage as required by the Industrial Insurance Laws of the State of Washington.

B. Self-insured Retentions

Self-insured retentions must be declared to and approved by the City.

C. Other Provisions

Commercial General Liability policies shall be endorsed to:

- I. Include the City, its officials, employees and volunteers as additional insureds,
- Provide that such insurance shall be primary as respects any insurance or self-insurance maintained by the City.
- 3. Each insurance policy shall provide that coverage shall not be canceled except after thirty (30) days' written notice has been given to the City.

D. Acceptability of Insurers

Insurance shall be placed with insurers with a rating acceptable to the City.

E. Verification of Coverage

Contractor shall furnish the City with certificates of insurance required by this clause. The certificates are to be received and approved by the City before work commences. The City reserves the right to require complete, certified copies of all required insurance policies at any time.

F. Subcontractors

Contractor shall require subcontractors to provide coverage which complies with the requirements stated herein.
