I. CALL TO ORDER

The meeting was called to order at 6:13 p.m. by Chair Neiman.

II. ROLL CALL

III. APPROVAL OF MINUTES

Motion by Boardmember Reil and second by Boardmember Bergeron to approve the April 3, 2012 Disability Board Regular Meeting minutes as presented. Motion carried unanimously (3-0).

IV. CONSIDERATION OF APPLICATIONS FOR DISABILITY ALLOWANCES

A. Applications for Disability Allowances

Motion by Boardmember Bergeron and second by Boardmember Reil to approve the Applications for Disability Allowances.

Boardmember Bergeron corrected Member #17's claim noting the number of hours off duty was 23 on 04/16/12, rather than 48 as stated in the Board packet.

At the question, motion carried unanimously (3-0) to approve the Disability Allowances.

B. Applications for Disability Allowances Greater than 1 month

V. CONSIDERATION OF MEDICAL CLAIMS

A. Routine Claims

B. Special Claims

Motion by Boardmember Bergeron and second by Boardmember Reil to approve the Special Claims as presented.

Boardmembers discussed the claims regarding Member #5. These claims were from 2007 spinal decompression therapy sessions. However the claims were never billed to Premera or the Disability Board due to internal personnel issue at the doctor's office. A 2012 letter from the doctor requesting payment for the therapy sessions, totaling \$3,595.00, was included in the Board packet.

Motion by Boardmember Bergeron and second by Boardmember Reil to amend the motion to remove the claim pertaining to Member #5 from the Special Claims list. Motion carried unanimously (3-0).

At the question, motion carried unanimously (3-0) to approve the Special Claims as amended.

Motion by Boardmember Bergeron and second by Boardmember Reil to deny the Special Claim related to Member #5 due to late submission of the claim.

Boardmembers discussed the Disability Board Policies and Procedures noting, "Claims for reimbursement for necessary medical expenses must be submitted to any applicable insurance carrier(s) within the time limit the carrier establishes for filing claims, but in no event later than one year after the date the expense is incurred." The claims regarding Member #5 were from 2007.

At the question, motion carried unanimously (3-0) to deny the claim related to Member #5.

VI. PRE-APPROVED RECURRING LONG TERM CARE CLAIMS

Pre-Approved recurring long-term care claims were included in the Board packet.

Motion by Boardmember Reil and second by Boardmember Bergeron to adopt the following amendment to the LEOFF 1 Policies and Procedures Section II, Item 11 Cancelled Meetings:

The Chair of the Disability Board or his/her designee may cancel a regularly scheduled Disability Board meeting with 24 hours notice where the Board has no necessary actions to take at a regularly scheduled meeting or for other reasons related to public health, safety or for good reasons making a meeting impossible or impractical. Notice of a canceled meeting shall be given on the Disability Board website.

At the question, motion carried unanimously (3-0) to approve the meeting cancellation amendment.
