"Dental charges incurred by a member who sustains an accidental injury to his or her teeth and who commences treatment by a legally licensed dentist within ninety days after the accident."

Boardmembers determined that the denture claim for Member #83 does not fall under these guidelines.

At the question, motion carried unanimously (3-0) to deny Member #83's claim for dentures and to approve the remainder of the Special Claims as presented.

VI. PRE-APPROVED RECURRING LONG-TERM CARE CLAIMS

The pre-approved recurring long-term care claims were reviewed and included in the Board packet.
