Reports:

Bellevue Friends of the Library

Ned reported that this year's Shakespeare in the Park event will be supported by the BFoL. The hours for the Book Shop are changing to reflect a later open and close.(opening moving to 11AM from 10 during the week and 1PM on Sunday). The change is due to the KCLS Safety and Security Policy not allowing persons who are not KCLS employees to be in the facility before regular business hours. Ned took the opportunity to direct attention to a recent article in the New York Times recognizing that Seattle is moving to become a "City of Literature"

Regular Business

Agenda Item 1 - Discussion of Meeting Time (Start later?)

The Board reviewed options for changing the start times for the monthly meetings based on the ability of members to attend (based on competing personal requirements) and the recently developed mission and supporting actions identified. Discussion of the history of the current scheduled times and changes to the composition of Board membership and possibilities for community engagement was engaged. Everyone reviewed and provided final comments to the proposed Library Advisory Board Mission Statement. The unanimous position of the Board was that the draft is ready for review by our City Council liaison prior to finalization and adoption. Chad will review with Council Person Robertson and gain agreement/feedback prior to the March meeting.
