- 10. Land Use
 - (a) Consideration of an application of the Bellevue School District for a Conditional Use Permit and a Critical Areas Land Use Permit to demolish the existing Odle Middle School and to construct a new two-story facility to serve grades 6 through 8. The adjacent Bellevue Aquatic Center will not be disturbed and will remain open during the construction process. The site area is approximately 18 acres and is located at 502 143rd Avenue NE, which lies in between 140th and 148th Avenues NE.

The project location is zoned R-4 and R-1.8 and is located within the jurisdictional area of the East Bellevue Community Council.

(Council discussion on this item was held on April 28, 2014. Staff previously provided the full Hearing Examiner recommendation to Council under separate cover.

DSD <u>10-1</u> Carol Helland Toni Pratt This is a Process III application. The site is located in the East Bellevue Community Council (EBCC) area. Under Process III, the Hearing Examiner makes a recommendation to the City Council, which is the decision-making body. Should Council approve the application, the matter will be heard by the EBCC.

Should Council deny the application, the decision is appealable to Superior Court.

The Hearing Examiner recommends Council approval of the amendment subject to conditions.)
